TRICKLE UP IMPLEMENTED OUR CORE GRADUATION MODEL THROUGH LOCAL PARTNERS IN BURKINA FASO, GUATEMALA, NICARAGUA AND INDIA. THE GRADUATION MODEL INCLUDES A CAREFULLY SEQUENCED SERIES OF INTERVENTIONS INCLUDING TARGETING THE POOREST FAMILIES, SUPPORTING THEM IN FORMING SELF-HELP GROUPS TO BUILD SAVINGS AND CREDIT, SELECTION OF AN APPROPRIATE LIVELIHOOD ACTIVITY WITH CLOSE AND REGULAR COACHING, AND THE PROVISION OF A SEED CAPITAL GRANT TO BEGIN THE LIVELIHOOD ACTIVITY.
