TRICKLE UP IMPLEMENTED OUR CORE GRADUATION MODEL THROUGH LOCAL PARTNERS IN BURKINA FASO, GUATEMALA, NICARAGUA AND INDIA. TRICKLE UP ALSO WORKED WITH GOVERNMENT PARTNERS AT THE MUNICIPAL, STATE AND NATIONAL LEVEL TO INCORPORATE THE GRADUATION APPROACH IN THEIR EXISTING POLICY IMPLEMENTATION TO BETTER REACH POOR AND VULNERABLE POPULATIONS. THE GRADUATION MODEL INCLUDES A CAREFULLY SEQUENCED SERIES OF INTERVENTIONS INCLUDING TARGETING THE POOREST FAMILIES, SUPPORTING THEM IN FORMING SELF-HELP GROUPS TO BUILD SAVINGS AND CREDIT, SELECTION OF AN APPROPRIATE LIVELIHOOD ACTIVITY WITH CLOSE AND REGULAR COACHING, AND THE PROVISION OF A SEED CAPITAL GRANT TO BEGIN THE LIVELIHOOD ACTIVITY. TRICKLE UP HAS A SMALL PROGRAM TEAM BASED IN OUR HEADQUARTERS OFFICE THAT PROVIDES OVERSIGHT AND TECHNICAL COORDINATION TO THE IN-COUNTRY TEAMS AND FACILITATES COORDINATION AND LEARNING ACROSS REGIONAL TEAMS AND WITH EXTERNAL ACTORS ACTIVE IN THE POVERTY ALLEVIATION SPACE. THE TEAM VISITS EACH OFFICE PERIODICALLY OVER THE COURSE OF THE YEAR TO PROVIDE TECHNICAL SUPPORT AND OVERSIGHT.
